We request you to kindly take the same on record.

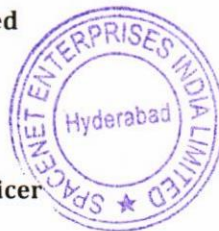

5. We draw attention to Note 6 of the statement, which describes the uncertainties and the impact of Covid-19 pandemic on the Company's operations and results as assessed by the management.

Our conclusion on the Statement is not modified in respect of above matter.

## Other Matter

6. The statement includes the results of Thalassa Enterprises Private Limited (Subsidiary) from December 21, 2021 to December 31, 2021. The Holding company acquired controlling right on December 21, 2021. Hence this is the first quarter and period for consolidated financial results.
7. The financial statements of the subsidiary, included in the consolidated financial results, whose financial statements reflect total revenue from operations of Rs. 208.20 Lakhs and total expenses of Rs. 200.35 Lakhs for the period from December 21, 2021 to December 31, 2021, has not been reviewed by us or by any other auditors. The financials have been furnished to us by the Management of the Holding Company. Our reporting on the statement, to the extent they have been derived from such unaudited financial statements / financial information is solely based on such statements of the Management.

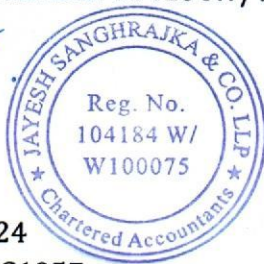
